## Business Operations of New Lubricants Sales Entity to Start in the Republic of the Philippines

JXTG Nippon Oil & Energy Corporation (President: Katsuyuki Ota, "JXTG") is pleased to announce that it has newly established a lubricants sales entity, JX Nippon Oil and Energy Philippines Corporation, in the Republic of the Philippines for the purpose of expanding its lubricants business in local markets. Business operations of the new sales entity began in January 2020.

The Republic of the Philippines is an attractive market with increasing motorization due to an expected annual population growth of around 2% and a steady GDP growth rate of around 6%. In addition, JXTG has been accumulating business knowledge and information through market research and sales support for its distributor business in the Philippines since it set up its representative office in Manila in May 2016. The new sales entity will take the remaining tasks, aim to meet its customers' needs in a prompt manner as well as build and improve a nationwide delivery network, and further increase our sales, including our private-brand products, "ENEOS Oil" to Japanese and local customers.

As of January 2020, JXTG has a worldwide network of 10 blending sites of our own and 31 sales offices. We will continue to take a proactive approach toward economically emerging markets, especially in Asia, and make efforts to expand our business.
