

BIO TURBINE 32

Biodegradable Turbine Oil

Equipment used in oceans, rivers and lakes always has a risk of oil leakage causing environmental pollution. Therefore, the demand for biodegradable lubricating oil is increasing as a measure to cope with environmental conservation. **BIO TURBINE 32** is a biodegradable general-purpose lubricant that meets this requirement, focusing the effect on "people", "environment" (biodegradability), "resource" (long life) as environmentally friendly lubricant. **BIO TURBINE 32** is classified as the JIS K 2213 2 species (with additives), and it is an Eco Mark product certified by the Japan Environment Association Eco Mark Secretariat.

● Special Features

1. It is a biodegradable general-purpose lubricant that passes Eco Mark certification criteria and has small effect on environment.
2. It has a flash point of 250°C or higher, and it also has flame retardancy.
3. Although it is biodegradable, it is excellent in oxidation stability and hydrolytic stability. It is the first kind in lubricant that satisfies both long life and biodegradability.

● Applications

It is used for equipment related to environmental pollution such as turbine bearings of hydroelectric power plants, sluice gate equipment, construction machinery, agricultural machinery.
